**PURSUANT** to sections 230, 606, and 692 of the Municipal Government Act, Statutes of Alberta, Chapter M-26, 2000, as amended, the Council of the Municipal District of Willow Creek No. 26 in the Province of Alberta hereby gives notice of its intention to consider Bylaw No. 1618, being a bylaw to amend Bylaw No. 1250, being the municipal Land Use Bylaw.

**THE PURPOSE** of proposed Bylaw No. 1618 is to redesignate the subject lands from "Reservoir Vicinity - RV" to "Grouped Country Residential - GCR". The lands that are the subject of the proposed land use district redesignation are as shown on the map in Schedule 'A' and are legally described as:

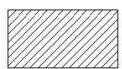
