PURSUANT to sections 230, 606, and 692 of the Municipal Government Act, Statutes of Alberta, Chapter M-26, 2000, as amended, the Council of the Municipal District of Willow Creek No. 26 in the Province of Alberta hereby gives notice of its intention to consider Bylaw No. 1629, being a bylaw to amend Bylaw No. 1616, being the municipal Land Use Bylaw.

THE PURPOSE of the proposed Bylaw No. 1629 is to redesignate the subject lands from "Rural General – RG" to "Rural Recreational - RR" in order to accommodate a proposed campground on the subject lands. The lands that are the subject of the proposed land use district redesignation are located within a portion of NE 36-15-28-4 as shown on the map in Schedule 'A' and are legally described as:

THAT PORTION OF THE NORTH EAST QUARTER OF SECTION OF THIRTY-SIX (36)
IN TOWNSHIP FIFTEEN
RANGE TWENTY EIGHT (28)
WEST OF THE FORTH MERIDIAN WHICH LIES WEST OF HIGHWAY
AND SERVICE ROAD ON PLAN 9210061 AND SOUTH OF CONNECTION
ROAD ON PLAN 9210061
CONTAINING 22.1 HECTARES (54.5 ACRES) MORE OR LESS

EXCEPTING THEREOUT ALL MINES AND MINERALS

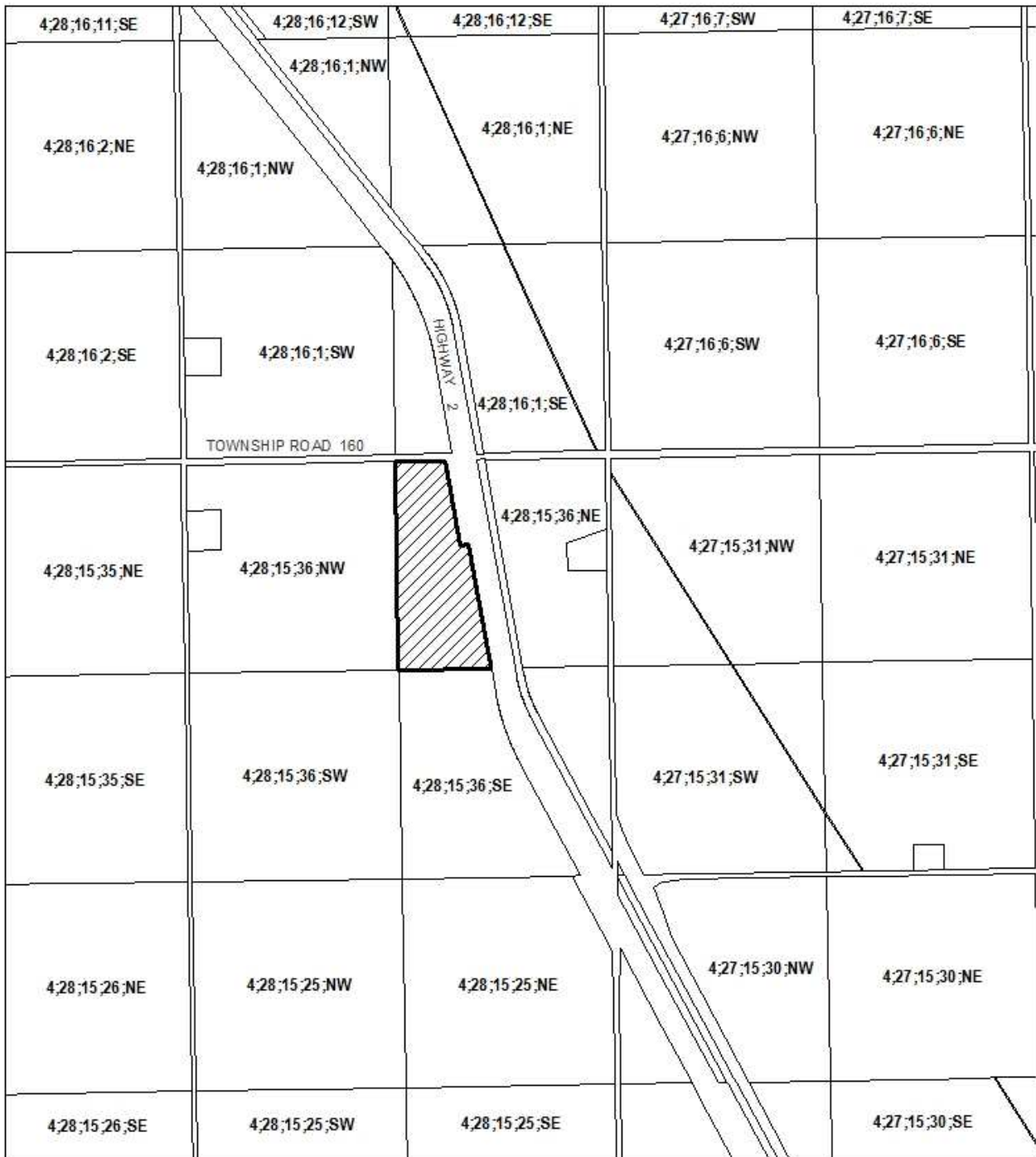
